Civil Mediation Program Panelist List

The Civil Mediation Program is a partnership of the Court, Bar Association and community. The Civil Mediation Program has pre-screened panels of attorney-mediators who are experienced in a wide variety of subject matter areas. Parties are welcome to choose a mediator who is affiliated with the Court's program or someone who is not, just as long as everyone in the case is in agreement. Payment

The Civil Mediation Program is a voluntary, market rate program. Fees are generally hourly and split equally among the parties. Mediators should be contacted regarding other charges and fee policies. For those parties who might have difficulty paying for mediation services, financial assistance is available through the Civil Mediation Program after an income-based screening is completed.

Stipulations

Local Rule 3-125(c)(3) states that following the case management conference, those parties who choose to participate in mediation have 21 days to file a *Stipulation and Order to Participate in ADR* identifying the name of the mediator agreed to by the parties and the date of the mediation session. Parties are expected to schedule the session directly with the mediator's office. A *Stipulation and Order to Participate in ADR* form is available on our website. IF the Court does not receive the completed *Stipulation and Order to Participate in ADR* by the deadline, the case may be set for an Order to Show Cause hearing.

Evaluations

Local Rule 3-125(h) requires submission of post-mediation evaluation forms within 10 days of completion of the mediation process. Evaluations are to be completed by both attorneys and clients.
